1. ST-86. Proposed Revisions to the *Statutes*, Article III, Sections 3 and 5, and Article VI – Dean, Director, or Campus Librarian. Passed UIUC Senate 4/27/20. Transmitted to UIC and UIS Senates 5/1/20. Passed UIC Senate 10/21/20. Passed UIS Senate 4/9/21.

The statutory revisions proposed by the UIUC Senate have been approved by the UIC and UIS Senates. The language is ready to be transmitted to the President, pending approval by USC.

2. OT-381. Review of the Process for Revising the *Statutes*.

The USC and senate chairs met with Executive Vice President Wilson to discuss the process for considering and approving revisions to the *Statutes*. The chairs will report on the meeting and there will be a follow-up discussion.

3. NC-27. Nominating Committee for 2021-22 Officers, Executive Committee, and USC Committees.

Professor Wade will appoint the committee in accordance with the *University Senates Conference Bylaws*, which state:

"The Chair of the University Senates Conference will appoint a three person Nominating Committee to be announced no later than the third from the last meeting of the academic year, including summer session. Each senate shall be represented on the Nominating Committee. The Chair of the Nominating Committee shall be designated by the USC Chair. At least one member shall hold a term that continues into the following academic year."

UIC Senate amendments transmitted to UIS and UIUC Senates 3/2/20. Passed UIS Senate 4/3/20. Passed with amendments UIUC Senate 4/27/20. Reconciled language approved by USC 5/29/29. Reconciled language to Senates 6/2/20. UIUC Senate USSP response 6/5/20. UIC SEC response 6/10/20 (The UIC Senate Executive Committee recommended that the struck sentence in lines 10-12 be retained).

USC approved sending the reconciled language of the Statutes and Governance Committee to the senates for information and any last comments. UIC and UIUC Senate committees have provided advice.

9. ST-85. Proposed Revisions to the *Statute*, Article X, Section 1 (Tenure of Academic Staff) (a) 6 and 7 – to permit the use of five-year appointments for non-tenure track faculty. Passed UIC Senate 4/22/20. Transmitted to UIS and UIUC Senates 5/1/20. Passed UIUC Senate 3/8/21. Passed UIS Senate 3/26/21. Transmitted to the President 4/5/21.
