3. OT-367. Clarification of the *General Rules* sections on intellectual property in relation to course materials.

The USC Statutes and Governance Committee has provided an interpretation of the *General Rules* section on intellectual property in relation to the ownership of course materials. This issue is timely now that many courses are moving to online delivery. The USC SGC requests that USC approve the statement and agree to forward it to the senates.
