4. OT-375. Discovery Partners Institute Bylaws.

The DPI Bylaws have been sent to USC for review and approval. The Bylaws were written by a working group composed of faculty across the system and included representation from USC, DPI's Academic Executive Committee, and DPI's Academic Governance Advisory Group.

5. OT-376. Consideration of a New System Officer Position.

USC has been asked to provide feedback on a proposed new position and to be ready to designate a USC member to be a part of a search committee.

The *General Rules*, Article I, Section 2, lists the system officers and indicate that, "such additional administrative officers as shall be designated by the president after consultation with the University Senates Conference."

The *Statutes*, Article I, Section 3 indicate that, "The university officers are identified in *The General Rules Concerning University Organization and Procedure*. Prior to recommending to the Board of Trustees the initial appointment of any university officer, except the president and the chancellor/vice president, the president shall seek the advice of the University Senates Conference.
