The UIC Senate approved the revised statement at its October 28 meeting. The UIS and UIUC Senates are still considering this item.

 OT-304. Open Access to Research Articles. Transmitted to Senates 10/21/14. Feedback from UIC Senate 10/19/15. Passed UIUC Senate with recommendations 10/19/15.

The UIC Senate provided feedback to USC on October 19. The UIUC Senate recommended approval of the policy and provided recommendations on October 19. The UIS Senate has discussed the policy but has not given a formal response.

 OT-310. Recommendation for New Policy Language Related to Classified Research at the University of Illinois. Transmitted to Senates 6/25/14. Passed UIS Senate 9/12/14. Withdrawn UIC Senate 1/29/15. Passed UIUC SEC 4/17/15.

The UIS Senate approved the policy. The UIC Senate withdrew the item from its agenda and decided to revisit the issue when more information becomes available. The UIUC Senate responded on October 29 that the SEC had approved the policy.
