Thursday, January 20, 2022 Chicago Ann Strahle

USC decided to give a report on the various roles of the faculty during COVID-19. An *ad hoc* committee was created to prepare the presentation. Professor Burbules volunteered to chair the committee, which also included Professors Benson, Danziger, and Weuve.

3. USC Discussion: How Senates communicate with each other

USC members discussed protocols for interactions among the senates, especially when dealing with statutory revisions. There was agreement that each senate should be in control of its own procedures and time frame. Once a senate completes its review of proposed language, the document should come to USC. The role of USC is to coordinate the actions of the three senates. If at least two senates are in agreement, USC has the ability to move a proposal forward. Professor Kar made the following motion, "If individual senates or committees within senates are processing something from USC concurrently, and they have information that might be relevant to another senate, the information should be sent to USC for consideration as to whether and how the information should be distributed." Professor Burbules seconded the motion. The motion was approved.

9. University Senates Conference Guests.

The Conference discussed guests to invite to future meetings.

10. University Updates.

Professor Wink said that the UIC Senate has been working on ST-83 and has been involved with Black Lives Matter issues. Professor Weuve reported that UIS is in the final stages of a massive reorganization effort and is searching for a new chancellor. Professor Kar said that the provost has issued a communication on promotion and tenure.

(The meeting recessed at 11:30 a.m. and resumed at 1:00 p.m.)

IX. Meeting with President Killeen, Executive Vice President Ghosh, Vice President Walsh

President Killeen congratulated USC members on the comprehensive and ambitious ten goals that USC developed. The budget request is ready to be presented to the Board in November. The budget request calls for a 10% increase, which is around \$60M. Elements of the budget include funds for competitive salaries, financial aid for students, the capital budget request, and faculty recruitment. The DPI contract with the architectural firm is in design mode. COVID-19 case numbers are being monitored. UIUC saw a post-Halloween spike. Both SHIELD Illinois and SHIELD T3 have ramped up. Approximately 2,000 schools are using SHIELD Illinois.

President Killeen discussed the state tour he, the chancellors, and others have completed. The two-leg tour covered 1,500 miles. They met with many people, including legislative leaders, community leaders, business leaders, university system presidents, and faculty. Throughout the state, the 15 Hubs of IIN (Illinois Innovation Network) have convened local community leaders to help fund their projects. The President raised the question of what the statewide responsibility is for the system. The group visited many Extension offices. The Extension is extremely active. Food insecurity and health care insecurity can be found in many downstate communities. Connecting IIN and Extension could be amazingly productive for many parts of the state.

Vice President Walsh commented that a lot was learned on the tour. Building relationships on Zoom is not the same as meeting in person. There were many corporate-focused visits in addition to the community visits. IIN was put together to improve the state's economy through innovation, research, and education. President Killeen said that Lieutenant Governor Stratton has accepted an invitation to be the Executive Sponsor of IIN in the Governor's Office. President Walsh said that each IIN Hub is connected to a specific university in the state. He stressed that collaboration among the universities is very important in furthering the state's economy and improving the quality of life for people throughout the state. IIN can help foster collaborations that connect people and organizations to build equitable and sustainable communities. The IIN Council includes the heads of each Hub. He encouraged greater communication within shared governance to promote a better understanding of what IIN does, especially to faculty who might be uninformed or misinformed. Vice President Walsh clarified that DPI is a Hub of IIN.

President Killeen said that the system is working to create a means to distill progress and keep track of the pillars of our aspirations that represent who we are and what we value. He commented that many of these aspirations relate to the ten goals of USC. He envisions a balanced score card approach.

EVP Ghosh discussed some of the goals that would be part of the tracking process: the future financial stability of the system, expectations that society has for higher education, expectations of inclusion, the future of education related to online learning, bridge programs and readiness programs for students from smaller communities, and connections with community colleges. The Enterprise Risk Management group has identified some important issues as well.

President Killeen discussed enrollment numbers at UIS and the academic reorganization process.

The group discussed USC's retreat topic, Hybrid Teaching, Learning, and Working in a Post-Pandemic University. President Killeen commented that the system has so many assets and so much experience in remote learning. We have partnerships with international connections that have the potential for large student bodies. The system also has incredible successes with the growth of certain online programs. EVP Ghosh added that this is an opportunity to also think about reaching non-traditional students.

There was a discussion of creating a culture of respect and collegiality at the universities and throughout the system.

SGC: Professor Burbules reported that the committee is revising the USC Bylaws.
