b. Discuss ST-83

- i. A proposal was made to discuss Senate feedback on proposed amendments to ST-83 article by article. The group discussed which articles to address first. Article X will be held for later discussion.
- ii. The group discussed a need to agree on guiding principles for the committee's work. Questions were raised about the history and purpose of ST-83: What was the "charge," and what is the proper scope of ST-83? Committee members discussed the historical relationship of ST-83 to ST-77. One issue raised at the start of the ST-83 process was the need for a definition of the term "faculty." The group discussed the breadth of the current definition of academic staff and its relevance to academic freedom.
- iii. The committee would like to see the initial charge that led to creation of ST-83. Mr. Perryn was asked to provide relevant documents.
- iv. Suggestions were made about how to move discussions ahead. Committee members noted the importance of involving HR to ensure titles are accurate. It was suggested we consider using a project management system to track the committee's work.
