MINUTES¹ UNIVERSITY SENATES CONFERENCE

Professor De Groote, Chair, called the meeting to order at 10:10 a.m.

I. <u>Meeting with President Killeen, Executive Vice President Barbara Wilson, and Dr. Phyllis Baker</u>

Professor De Groote congratulated President Killeen on his extended contract that was recently approved by the Board of Trustees.

President Killeen commented that the tuition increase item on the agenda of the January 16 Board of Trustees meeting led to quite a bit of commentary. The 1.8% increase felt timely after the five-year tuition freeze and will add \$9M to the budget. The funds will be used primarily for renewing the faculty but will also go towards retention and support for the whole enterprise. There has been a 14% increase in enrollment and only a 3% increase in faculty. The President said that Executive Vice President Wilson is still working intensely on the stellar faculty recruitment program, which has brought 19 faculty to the system.

President Killeen told the Conference that the Urbana university will raise the Illinois Commitment eligibility amount from \$61,000 to \$67,000 at the request of Governor Pritzker. The Illinois Commitment provides four years of free tuition for students whose family incomes are at or below this amount. Executive Vice President Wilson commented on information that was in a slide presentation given at the Board meeting that illustrates how much students really pay in tuition after financial aid is applied. As an example, almost 40% of UIC students are paying less than \$2,000 for tuition.

President Killeen discussed some current system issues, such as the need to increase lifelong learning and connections with alumni, interest from industry in reskilling and upskilling mid-career employees and how DPI (Discovery Partners Institute) might address those issues, and the system's investment strategy.

In response to a question about the net number of students who transfer in and out of the system, Executive Vice President Wilson said that she would get those numbers. She explained that the increase in students is mostly due to incoming freshman. President Killeen added that the loss of high school students going out of state has been an issue. He said that the system needs to make sure the U of I brand is known as an affordable place where students can graduate on time with less debt.

Dr. Phyllis Baker, DPI Director of Academic Affairs, said that she has been with DPI for two and a half years. The new Executive Director, Bill Jackson, has been on the job for two weeks. She commented that Mr. Jackson plans to meet with USC on February 20 and will go over the DPI business plan and economic impact study.

Dr. Baker said that the DPI business model was developed by collecting data for several months while working with DPI partners, industry, stakeholders, and the governor. Nine programs were prioritized. The economic impact study includes the Illinois Innovation Network (IIN). A feasibility study is being built. A letter of intent has been finalized. Dr. Baker indicated that the DPI Bylaws will be determined by the DPI affiliated faculty members. Letters will be sent out to faculty members who have been working on DPI inviting them to become members. There will be a vetting process for those who are interested.

The charge for the eight working groups was up at the end of 2019. There are now theme leaders in the same eight areas. Faculty are being engaged in meaningful ways across the system to define the roles and functions in each area. There will be five DPI directors.

Dr. Baker said that intellectual property matters will follow the same process as the system. Departments will be involved in defining academic programs. She said that USC would be involved and asked that USC members be ambassadors for DPI. She added that USC's advice will be needed on matters of faculty governance. President Killeen commented that there will be leadership opportunities and all three universities should be represented.

Dr. Baker clarified that academic programs will be coordinated by her office.

Executive Vice President Wilson said that the sexual misconduct system policy will be coming back to USC for feedback. There are three policy areas. While the policy will be systemwide, implementation issues will be localized.

II. <u>Meeting with Alumni Leaders: Jennifer Dillavou - Urbana, Caryn Korman - Chicago, Charles Schrage - Springfield</u>

Professor De Groote introduced the Associate Vice Chancellor for Alumni Relations from each university and thanked them for meeting with USC.

Ms. Korman provided a history of the University of Illinois' alumni relations office, which was started in 1873. In 2015, the Alumni Association became three separate alumni relations offices. Ms. Dillavou said that there is still oversight from the University of Illinois Alumni Association Board. There is also an Alumni Alliance for the purpose of providing support to each of the alumni relations offices and initiating engagement among the offices.

The three alumni leaders went through a presentation that highlighted the many programs, ongoing activities, and special events of their operations. They discussed the various ways they communicate with and keep track of alumni, how social media has played a huge part in how they engage with alumni, and how they are working on best practices.

The group discussed ways faculty can assist with alumni relations and engagement.

A system-wide policy is

being developed that will address what each university should do in terms of screening out hires who have been found to have engaged in sexual misconduct. She discussed some of the challenges of obtaining background information.
