Professor Nicholas Burbules, Chair, called the meeting to order at 10:00 a.m.

I. <u>Remarks from the USC Chair</u>

Professor Burbules reported on possible upcoming guests at USC meetings. He also told the Conference that there will be a report later this spring regarding UI Foundation and Alumni Association collaborations and their relationship with the campuses.

Professor Burbules commented that the draft recommendations from USC were sent to the Strategic Planning Steering Committee. He asked if the Conference wanted to formally approve the document. Professor Vincent said that she would like the opportunity for more feedback. Professor Vincent said that the faculty on the steering committee requested that a document be posted soon for faculty feedback.

16. Campus Updates.

Professor Vincent reported that the new UIC provost, Susan Poser will begin on February 1. Professor Burbules noted that the UIS Provost, Lynn Pardie, will be retiring this spring.

Professor Weech reported that Vice President Knorr's FAC met and discussed the group's mission. Professor Jackson reported on the Enrollment Management Policy Council meeting.

VII. Meeting with President Killeen and Vice President Pierre

President Killeen discussed the effects of the state budget impasse and what is being done in response. Some of the public universities will be struggling to make payroll very soon.

The public university presidents have sent communications to the governor and legislature warning of the dire consequences of the impasse on the institutions and on the state. If the impasse continues through the fiscal year, the University will have taken a \$650M hit to its operational budget. The President discussed the University's 2021 Initiative, which proposes a compact with the state. The University would guarantee progress in certain areas and cost containment, which would be documented on a report card, and the state would guarantee a predictable budget and offer some regulatory relief. The President commented that the University is a world-class economic engine for the state. Vice President Pierre reported that searches are proceeding for the most part and enrollment figures are holding up. The University footed the MAP bill for the fall, which was around \$30M, but cannot continue to cover the expense.

President Killeen expects to have a draft of the strategic planning document available sometime in February. The steering committee has been meeting regularly. Campus cultural issues are being built into the document. He commented that he looks forward to full participation from USC and that input will be timely. The group discussed the importance of engaging the senates. The President said that there will be the need for shared governance on the metrics of the compact. Conference members asked that drafts of the strategic plan and of the compact be shared as soon as possible. President Killeen said that a number of things will be happening in parallel: the strategic plan, the compact, and the fundraising campaign.

Vice President Pierre reported that a committee will be looking at the academic program approval process. The process, which ends with IBHE, is too long. He asked for suggestions for the membership of the committee.

Vice President Pierre said that the Enrollment Management Policy Council is working on a 5-year plan. The group is taking a comprehensive look at increasing enrollment growth, including issues of added costs, tuition revenues, undergraduate and graduate numbers, instate and out-of-state numbers, increasing community college transfers, the impact on diversity, retaining quality and reputation.

President Killeen provided an update on the hospital and medical enterprise. The hospital was in the black last year but is running close to the line. Payments that used to be made directly from the state to the hospital are no longer timely, so the cash position of the hospital is a concern. A transition team is addressing issues related to the change from a Vice President of Health Affairs to a Vice Chancellor for Health Affairs at UIC. Dr. Bob Barish arrives on February 1. There is a search underway for the Dean of the College of Medicine at Urbana.

Professor Burbules thanked President Killeen and Vice President Pierre for ending the background check policy process much better than it started. He suggested that, for future initiatives, consultation begin as early as possible.
