# MINUTES<sup>1</sup> UNIVERSITY SENATES CONFERENCE

Professor Kathryn Eisenhart, Chair, called the University Senates Conference to order at 9:05 a.m.

### I. Approval of University Senates Conference Minutes of January 22, 2010

#### III. Old Business – Action Items

There were no action items.

#### IV. New Business

The Conference discussed the polarization among various faculty groups. Professors Burbules, Massat, and Ting talked about the pressure the leaders of the senates are feeling. There have been a lot of distortions of facts and misunderstandings about the role of faculty leadership. Some members commented that the situation may not be widespread. Professor Francis said that one problem that may have exacerbated the situation is that furloughs should have been made more clear in that the affected paychecks are actually a 6% deduction, not 2%. Professor Ting said that this is explained on the furlough website, which also includes a pay calculator. Professor Campbell said that some people thought that furloughs would prevent having to let some employees go. Professor Kaufman reminded the group that the Conference embraced furloughs two years ago as a way for faculty to share the burden since faculty cannot be laid off. Furloughs is one of many things that need to happen to solve the budget problems. Also, the budget situation has gotten much worse since then.

Professor Chambers commented that this is the beginning of major restructuring of the University. Some people do not realize that the crisis has just begun. He also commented that no one is defending us regarding the pension system, which is in trouble because the state has not paid into as it should. Professor Wheeler said that the pension system exists because it saves the state money, since the state does not have to pay the social security employer tax.

Professor Tolliver expressed concern that some faculty are putting too much energy into complaining that the budget problems are a result of bad management in the past by the administration of the University. She said that it is urgent for the senate leadership to come to grips with the need to plan for the future. The Conference was in general agreement that there needs to be more sharing of information and faculty involvement in the decision-making processes because faculty are very concerned about their futures.

Professor Jones commented that there needs to be more discussion of balancing the budget. There are too many perceived needs and not enough resources to support them. Professor Wheeler said that the problem now is not exceeding our budget, but rather not getting the money that the University has been promised.

Professor Burbules said that the Urbana campus is already in the process of reviewing programs. The Senate Executive Committee has tried hard to assure that there is faculty representation at all levels of the review processes and to be seen as advocates for the faculty.

#### V. Executive Session

Vice President Knorr said that the University has been told by the state that there will not be a rescission this year. However, the University has been given no indication of when the state money that is owed will be received. The state has \$4.2B in bills to pay, and that number will probably reach \$6B by the end of the fiscal year. The University has been told to plan for cuts in FY11. The University may have to consider short-term borrowing. Vice President Knorr explained that the \$800M in General Funds are mostly restricted. When asked why Foundation money could not be used or borrowed from, he responded that these funds are dedicated to a specific purpose. Donors must be able to trust the University to use their donations according to their intended purpose. There is no certainty when the University would be able to pay back the Foundation. A suggestion was made to communicate to the public that the \$800M is restricted funds.

Vice President Knorr commented that furlough savings of \$17M does not seem like much against the \$478M budget problem. The University chose to do something to help the cash flow situation rather than do nothing at all. Furloughs are only one part of the package. Vice President Rao said that furloughs allowed units to give back 6% of their budgets rather than 8.5%. Some Conference members stressed that units need to know the reality of the situation in order to plan for the near future.

President Ikenberry said that there are university-level and campus preparations for a 15% reduction in GRF next year, which is \$111M. College and departmental units will probably see a 7-8% reduction in their budgets. However, with the cash flow problems, the University will continue to deal with uncertainties. When asked why some searches are continuing, the President responded that some exceptions have to be made to the hiring freeze. Concerning tuition, there are many things to consider when determining how aggressive the University can be. The University does not want to price itself out of the market.

President Ikenberry commented that he has stated that pension reform needs to be a part of the budget solution for the State of Illinois. When asked how the University's pension system compares to those of peer institutions, the President said that one difference is our system is defined benefit rather than defined contribution. The problem is not that the benefits are overly generous, but that the state has not paid into the system as it should. In response to a question, Vice President Rao reported that Human Resources, Legal Counsel, and SURS are looking into whether employees can buy back their furlough days in the pension system.

President Ikenberry suggested that faculty get involved in decision-making processes at the campus level. He added that the senates seem to be in the strongest positions to take on leadership roles. While some members of the campus communities do not understand and criticize shared governance, most colleagues have respect for the work of senate leadership.

Vice President Knorr said that tuition collection is good. However, MAP funding has not been received. Vice President Rao said that the three campuses put a combined \$35M into financial aid.

President Ikenberry discussed activities and recommendations of the Administrative Review and Restructuring groups. The review should initiate cost-savings and improved performance of the University.

President Ikenberry reported that the presidential search is moving along well. There is a good pool of candidates.
