MINUTES¹ UNIVERSITY SENATES CONFERENCE

DATE: Thursday, February 23, 2017

Professor Novak, Chair, called the meeting to order at 10:05 a.m.

I. Meeting with President Killeen and Vice President Wilson

President Killeen welcomed Dr. Avijit Ghosh, Chief Financial Officer of the UIC College of Medicine, who is leading the implementation of the University Administration Alignment process. Dr. Ghosh commented that University Administration is now called University of Illinois System Offices. He listed some of the areas that benefit from being centralized, such as governmental relations, legal counsel, strategic procurement, advocacy, audits, ethics and compliance, and treasury. Operations at the system level should either provide cost savings or efficiency gains.

President Killeen provided updates on the current searches for the Special Assistant to the President, the Vice President for Economic Development and Innovation, and the Federal Director of Governmental Relations.

President Killeen mentioned that the last presentation to the Board on the University's strategic framework included strategic enrollment and the tuition announcement. The next presentation to the Board will focus on Pillar 2; scholarship and impact, highlighting new initiatives in the arts and humanities. The group discussed some of the challenges of recruiting faculty and explored ways to attract the best faculty and students.

President Killeen invited Ms. Lindsay Anderson, Executive Director of Governmental Relations, to provide a legislative update. Ms. Anderson said that the driving conversation will be on delivering a state budget. The University of Illinois Investment, Performance, and Accountability Commitment (IPAC) bill has been refiled in both the house and senate. IPAC attempts to redefine the relationship between the University and the state.

Responding to a question, Ms. Anderson said that the University has aggressively opposed the bill that would automatically admit all Illinois high school graduates who are in the top 10% of their class. The President commented that it is very dangerous to have the legislature involved in the admissions process.

Ms. Anderson said that the "grand bargain" is a complex package of bills where the entire package fails if even one bill fails. She clarified that IPAC is a different, stand-alone initiative. Mr. Devocelle added that the grand bargain contains a state budget for FY17 and FY18 and both the grand bargain and IPAC include procurement relief. President Killeen said that the grand bargain includes 90% funding for FY17 and FY18. Regardless of what the state does, the University will present an FY18 budget to the Board of Trustees in September. The President said that the stop gap funding ended in January.

Ms. Anderson commented on the federal travel ban, saying that another executive order appears to be forthcoming to replace the January 25 executive order. She said that her office is advocating for green card and visa holders to be excluded. Concerns were expressed from the Conference regarding the impact the travel ban might have on students who come to the University from other countries and are important to research programs. Losing them would make a very negative impact on some programs.

Ms. Anderson said that there has been no new information on healthcare benefits that have to be negotiated with AFSCME or pension reform.

President Killeen discussed the University's ongoing efforts to work with private sector companies in Illinois to help solve complex problems with the expertise of the three universities. Mr. Devocelle added that here are many opportunities for the University to help move the state's economy forward; one being by helping companies remain technologically advanced.

Vice President Wilson said that there will be a review of the Institute of Government and Public Affairs (IGPA) to look at its functions, vision, and funding. She would also like to figure out how the unit can operate without permanent tenure-system lines.

President Killeen said that a UA Alignment group looking at the University Foundation and Alumni Association have made specific recommendations. Advocacy will still remain central, but focus will be more on each individual university. The governance structure is still being worked out. There will be more clarity in the direction of philanthropic efforts and donors will have a clearer understanding of strategic plans of the universities.

The meeting recessed for lunch at 12:30pm and resumed at 1:15pm.
