MINUTES¹ UNIVERSITY SENATES CONFERENCE

Professor Jorge Villegas, Chair, called the meeting to order at 10:03 a.m.

I. Remarks from the USC Chair

Professor Villegas reviewed the day's schedule. He noted that President Easter would join the meeting at 10:30am, Chairman Kennedy would arrive around 11:30am, and Chancellor Wise was scheduled for 2pm.

IV. Old Business – Action Items

1. OT-307. Leadership Development Program (UI Succession Planning).

The Conference discussed the 4-day program and decided to wait to nominate someone until after the discussion with the President. There was general agreement that leadership training should be occurring at all levels. The group also discussed the difference between leadership preparation and administrative training.

V. New Business

3. NC-20. Nominating Committee for 2014-15 Officers, Executive Committee, and USC Committees.

Professor Villegas reported that he had appointed the committee: Kouros Mohammadian (Chair), Lynn Fisher, and Kim Graber. He commented that the committee cannot do much until the senates elect USC members.

4. OT-309. Presidential Search.

Professor Villegas commented that the Board approved the composition of the search committee at its March 6 meeting. The senates have been asked to suggest candidates for the committee. There was discussion of whether the senate nominees should be transmitted through the Senates Conference, as outlined in the Board document. Some conference members felt that the nomination procedure should be defined in writing, possibly even in the *Statutes*.

5. OT-310. Recommendation for New Policy Language Related to Classified Research at the University of Illinois.

Professor Villegas said that the working document from Vice President Schook would be discussed with him at the April 22 USC meeting. The Conference decided to transmit the document to the USC Academic Affairs and Research Committee for review.

VI. Meeting with President Easter

President Easter commented that the Board would like to see better succession planning at the University. He will be gathering a cohort of people who might be ready to step into certain roles. The initiative will give the group experiences that would provide them with a good background, particularly with legislators. He is planning a four-day program that includes one day on each campus and one day in Washington, D.C. The President said that he would like one member of USC to participate in the program.

President Easter said that ST-72 should be ready to move forward. Peg O'Donoghue mentioned one editorial revision where a subsection is referenced that has been removed. She thanked the group that worked on the language. Professor Fisher gave credit to Professor Tolliver, both of whom were a part of the working group. Professor Tolliver acknowledged the work of Professor Eric Johnson from the Urbana Senate, whom she consulted on various occasions.

President Easter reported that the July Board of Trustees retreat will be fairly small and include conversations among the trustees, representatives from USC, the chancellors, and the provosts. Core issues will be discussed in the context of the presidential search. The senates have been solicited for faculty nominations for membership on the search committee.

President Easter remarked that the administrative review came to closure a little over a week ago. Mr. Bill Adams said that 45 of the 47 recommendations were approved. Each recommendation has been assigned to its responsible leader. The President added that Vice President Pierre has been made the task master of implementing the recommendations. The recommendations make sure that University Administration is serving its customers. In addition, there will be a formalized budgeting process for UA.

President Easter said that the University was asked by the state to prepare scenarios for a 12% and a 20% budget reduction. He commented that he would be testifying before the

House and Senate Appropriation Committees before the Governor gives the budget address. The request for information on the budget reductions has to do with the potential impact of the income tax hike expiring as it is set to do. Some groups have proposed stepping down the tax gradually and then implementing other taxes.

In response to a question about "one University," President Easter responded that we are a University with very distinct campuses that need a lot of autonomy. He added that we do not have the resources to be totally autonomous. There needs to be strategic coordination and a way to look at areas where there may be redundancies.

VII. Meeting with Chairman Kennedy

Chairman Kennedy joined the meeting at 12:45 p.m. He stressed the importance of bringing clarity to the role of the president. The University should determine its mission and then develop a strategy for moving forward. Part of the strategy includes developing the correct structure. Mr. Kennedy said that he believes decisions should be made at the lowest level possible. As the University looks for a new president, we need to think about the relationship between the president and the chancellors and centralization and decentralization. He considers being adaptable one of the strongest qualities needed in a president. Mr. Kennedy commented that a search firm would be used as part of the presidential search, but the search committee will have an active role. Dr. Kies confirmed that the senate nominees to the search committee would go through the Senates Conference to the Board.

Mr. Kennedy commented that the University needs to have a bigger influence in government by overcoming its hesitation to be politically involved. He acknowledged that there are restrictions that must be considered.

Mr. Kennedy annunciated the role of the Board of Trustees: to hire the President; to develop the University strategic plan; to approve campus strategic plans; to maintain resources of the University and to distribute appropriately per the University's strategic plan; to develop compensation plans for employees; and to assure compliance in order to achieve goals.

VIII. Meeting with Chancellor Wise

Chancellor Wise joined the meeting at 2:10 p.m. She commented that the economic situation with the state is currently the biggest challenge. Illinois is one of the last states in the nation to recover. The President has asked the campus to prepare a budget with cuts as much as 20% in the event that the income tax increase is discontinued. The scenarios are being written to protect excellence and to maintain scholarships for the neediest students. She cautioned, however, that deep cuts to the budget would result in less financial aid for students, less teaching assistants, and less course offerings.

Chancellor Wise said that the University is working very hard on a supplemental pension program. She commented that, in order to retain faculty, the University has to be competitive.

On the positive side is economic development on the campus. The Chancellor stressed the importance of technology driven healthcare and ensuring that the research park is an attractive place for companies that want to recruit our students and work with our faculty. There is a push for globalization and online learning. The campus has set up an office in Shanghai and one will open up in Delhi within a year. The campus has eleven Coursera courses. She said that online teaching should be faculty-driven.

Chancellor Wise commented that the President should be externally facing; working with corporations and with legislators to promote the value of higher education. The President should be a leader in higher education both in-state and nationally.

Responding to a question about collaborations among the campuses, Chancellor Wise said that collaborations should be complementary. There should always be awareness when there is overlap, but that does not mean there should be a restriction.

IX. Old Business – Information and Discussion Items

(1.continued) OT-307. Leadership Development Program (UI Succession Planning).

The discussion was continued from the morning session. The Conference decided that it might be beneficial to have two faculty members participate in the leadership program. Professors Deberry-Spence and Villegas were elected to have their names put forward, with Professor Deberry-Spence being the nominee if only one person is permitted to participate.

6. ST-72. Revisions to the *Statutes*, Article X, Section 2 (Academic Freedom). Passed UIUC Senate 12/6/10. Passed UIC Senate 9/22/11. Passed UIS Senate 12/14/12. Transmitted to the President 1/18/13. Letter to President 9/25/13.

Professor Tolliver noted the editorial revision pointed out by Peg O'Donoghue. In the third to the last line in section, "of Article X, Section 2c" should be removed. The Conference also decided to change "the" to "these" in the same sentence, and delete the word "paragraph" in the first sentence of c. Professor Chambers moved to approve the revisions and send the proposed statutory language to the senates.

7. ST-79/OT-296. Proposed revisions to the *Statutes*, Article XIII, Section 8 – to authorize the University Senates Conference to initiate revisions to the *Statutes*. Approved by USC 1/17/13. Transmitted to Senates 4/5/13. Revised language approved by USC 6/18/13. Transmitted to Senates 6/21/13. Passed UIC senate 9/26/13. Alternate language passed UIUC Senate 11/18/13. Transmitted to Senates 11/26/13. Passed UIS Senate 2/21/14.

Professor Mohammadian reported that the UIC Senate had first reading of the revised language.

8. ST-77/GR-46. Revisions to the Statutes and General Rules – Edits and Updates.

Professor Tolliver reported that the members of the committee reviewing the documents are supposed to share their thoughts on the proposed revisions by April 1.

9. OT-298. Shared Governance in a Changing Environment.

No new information.

10. OT-304. Open Access to Research Articles.

Professor Villegas reported that the Open Access Task Force met the day before. The USC committee is working on a guiding document that would be sent to the senates. A draft document should be ready by the next USC meeting.

11. OT-308. UA Annual Review Process.

Professor Villegas said that the names of the USC nominees to serve on the evaluation committee had been sent to Vice President Pierre. The nominees are: Danilo Erricolo, Lynn Fisher, George Francis, Kouros Mohammadian, Jorge Villegas, and Matthew Wheeler.

12. OT-288. Faculty/Staff Pension and Benefit Issues (formerly Resolution on Pensions/Pension Reform).

Professor Villegas said that the administration is working on a supplemental pension plan. He commented that there are many issues to be considered.

13. OT-223. Annual Review of the Vice Presidents.

Professor Campbell reported that a draft document on the review of Vice President Knorr had been circulated to the Budget Committee.

14. OT-297. Implications of the Open Meetings Act to the operations of the University Senates Conference.

No new information.

15. OT-301. Records and Information Management Services (RIMS).

Professor Fisher reported that meetings are being held at each campus.
