Professor Donald Chambers, Chair, called the meeting to order at 10:05 a.m.

#### I. Remarks from the USC Chair/Discussion of Agenda

Professor Chambers reminded the Conference that at the September retreat the group set the goal of working towards the greater good of the University and the campuses. He said it was his hope that, over a period of time, the Urbana-Champaign campus would be in the top four public universities in America. According to a recent Times of London lead table, or rating, Berkley is #1, UCLA is #2, Michigan is #3, and UIUC is #4.

Professor Chambers commented that another goal that was discussed at the retreat was to restore harmony and build synergy with all three campuses. He said that he reported to the Board of Trustees that there is now collegiality and harmony within the Senates Conference and three new USC members from UIS are on board. He also noted that he and Professor Burbules had a productive meeting with Chancellor Koch and Vice Chancellor Pardie the day before the Board of Trustees meeting.

Professor Chambers said that the cross-campus dialogue would take place during the Board of Trustees retreat on July 18. The Conference discussed general plans and the need for preliminary discussions among the Conference so there would be consensus on the issues discussed.

#### VI. Old Business – Action Items

2. OT-282. USC ad hoc Committee to develop more specific standards for implementing the existing USC Confidentiality Guidelines.

Professor Chambers and the committee members, Professors Andersen, Graber, and Mohammadian, commented on how well the group had worked together. Professor Andersen, chair of the committee, made the general observation that the Conference needs to do more work in committees. He explained that there were no UIS members on the committee because the members at that time declined to serve.

Professor Andersen commented that the language in parenthesis towards the top of each page – Privileged and confidential draft document for discussion purposes – was suggested by Legal Counsel. This makes it clear that documents are confidential until approved by the corresponding group at which time they become a public document. Professor Andersen said that he made modifications to make the *USC Confidentiality Guidelines* coherent. The committee took out the notion that the Executive Session is the official title for the meeting with the President. Instead, executive sessions are closed sessions. Professor Chambers suggested that the language be changed to "closed session". Professor Andersen said that the most significant change to the document was the new section 4 – *Confidentiality of Draft Documents*. On behalf of the committee he moved adoption of the document. The motion was seconded.

Professor Burbules suggested that the last sentence in section 2 end with the word *views*, so that *unless the link is relevant* would be removed. Professor Andersen agreed to the change and there were no objections. Professor Andersen asked if the Conference wanted to change "executive session" to "closed session". Professor Burbules clarified that a discussion of a formal body, such as USC, is always an open public meeting unless dealing with specific material that justifies making the decision to go into a closed session.

The discussion was postponed to later in the meeting due to the arrival of guests.

# VII. Guests

Steve Veazie, Deputy University Counsel, and Roopali Malhotra, Assistant University Counsel, met with the Conference to discuss the Open Meetings Act (OMA). Mr. Veazie said that there has been a succession of changes to the Open Meetings Act over the past decade; many of the changes have made it more difficult to hold a closed meeting. Some of the rules do not fit well with public universities. Recently put into law is the addition of a Public Access Counselor (PAC) who is part of the Attorney General's Office. The PAC works to ensure compliance with OMA and Freedom of Information Act (FOIA). Ms. Malhotra added that the PAC has the authority to issue advisory opinions and binding opinions. Mr. Veazie said that the PAC does not always have the final word. There are specific procedures outlined if an appeal goes to a court of law.

Mr. Veazie and Ms. Malhotra addressed a series of questions that had been given to them before the meeting. They clarified the following.

- Anyone can record during an open meeting as long as it does not cause disruption to the meeting. There does not have to be disclosure that recording is taking place.
- There must be a verbatim recording of a meeting that is in closed session.
- When a group meets socially, OMA does not apply. There must be the intent to have a meeting.
- The Board of Trustees or any body that is advisory to the Board is a public body.
- The cabinet or advisory body to a single official, such as a chancellor, would not be a pubic body because it is not constituted by an official University policy, such as the *Statutes*. If there are questions, determination would be made by a case by case analysis.
- Any USC standing committees would be under the same constraints of OMA. An ad hoc committee would be less clear, and might depend on whether the group is a majority of quorum of the entire USC body.
- If there is intent to discuss public business electronically and the means is contemporaneous and interactive, OMA would qualify.

- Discussions by email to gather opinions for creating a draft document that will be brought to a public meeting is not subject to OMA. This would be true for both standing and ad hoc committees that seek input from USC members. Soliciting opinions by email for a draft letter would not be subject to OMA.
- Attending a meeting by phone or video is only permitted if there is a quorum of the members of the public body physically present, and if the member is prevented from attending due to personal illness or disability, employment purposes or the business of the public body, or a family or other emergency.
- Trying to obtain information on how the body would vote would not be allowed outside of a public meeting.
- The USC Executive Committee conference calls would not be subject to OMA if they are for the purpose of planning an agenda for a meeting and deliberating public business is not part of the discussion.
- All members of a public body must complete OMA electronic training.

Mr. Veazie said that some of the interpretations of OMA seem to be over-reaching. He said that he would key in on whether there is intent to convene a meeting to conduct business as opposed to sharing information. He said he believes that an ad hoc committee created to draft a response that will go before the entire USC in a public meeting would not be subject to OMA. Ms. Malhotra added that whether deliberation to make a final decision is involved would be a factor in making a judgment call.

The Conference requested a written response to the questions. The group thanked Mr. Veazie and Ms. Malhotra.

## VIII. Meeting with Vice President Pierre

Professor Chambers moved to go into closed session at 1:30 p.m. for the purpose of discussing University employment. The motion was approved. The closed session ended at 1:40 p.m.

Vice President Pierre commented that the purpose of the President's Award Program (PAP) is to increase student diversity and provide need-based funding to recruit and retain high-achieving students. The program is mostly for underrepresented minority students but is also open to low-income students and students from underrepresented counties. The program started in 1985 with 110 students. Now there are over 1,000 new freshman PAP students each year. He reviewed the student profile and graduation rates.

Vice President Pierre said that there is special mentoring for PAP students. The group discussed factors that can prevent students from succeeding: inadequate high school preparation, working while going to school, being a first-generation student, and lack of

support from home. The group also discussed ways to work with high schools and community colleges to better prepare students.

Vice President Pierre described enhancements to PAP that were initiated this year. Award levels have been increased and there is a minimum GPA requirement. The award is now open to a limited number of transfer students. The award has been raised to \$5,000 a year for four years. A minimum GPA must be earned to retain the award. Also, there is now a PAP Honors pilot program for 200 students that doubles the award and requires a higher minimum ACT and HSPR. Vice President Pierre discussed how the program is funded by University Administration and the campuses. The campuses are responsible for screening the students. He clarified that PAP is for in-state students.

Vice President Pierre said that PAP acts as an incentive for the campuses to recruit more minority students with a certain ACT and high school rank because funding is distributed accordingly. Members pointed out that departments must then provide support for these students to succeed.

Professor Chambers commented that the success of the final enrollment management report was a function of Vice President Pierre and Special Assistant Ghosh being responsive to the concerns of the faculty. He thanked the Vice President. (The Conference responded with a round of applause.) Vice President Pierre responded that he was happy to take part in the enrollment management conversations and he was pleased with the final document. A number of activities are ready to begin implementation discussions. The group discussed course transfer among the campuses and between campuses and community colleges.

Vice President Pierre discussed recruitment programs for underrepresented minority faculty. He reviewed the tenure-system faculty profile and noted that numbers are low for underrepresented junior faculty, especially at the assistant professor level. The group discussed the difficulties of recruiting as well as retaining underrepresented faculty members. Vice President Pierre commented that the proportion of minority faculty at the University is related to the number of minority doctorates that are conferred. It will be difficult to solve the underrepresented minority faculty problem until the doctorate pipeline is resolved. He discussed the various campus and University Administration recruitment programs, including the new IDEA initiative (President's Initiative for Diversity Excellence & Advancement).

Professor Chambers thanked Vice President Pierre for the candor of the discussion and commented that the Conference would invite him back.

The Conference discussed the use of "executive session" or "closed session" and agreed to "executive session" lower case. Professor Andersen moved adoption of the revised *USC Confidentiality Guidelines*. The motion was approved unanimously.

Professor Andersen referred to the document, *USC Guidelines for Conduct of Business*, and moved adoption on behalf of the committee. After a brief discussion, Professor Andersen withdrew his motion and moved to postpone action to the next meeting. The motion was seconded and approved. He asked that additional suggestions be sent to him, Professors Graber and Mohammadian.
