# MINUTES<sup>1</sup> UNIVERSITY SENATES CONFERENCE

DATE: Tuesday, March 30, 2010

Professor Kathryn Eisenhart, Chair, called the University Senates Conference to order at 10:05 a.m.

## I. <u>Executive Session</u>

President Ikenberry and the Conference members discussed administrative reorganization ideas that are being considered by the Administrative Review and Restructuring Working Group. The group also discussed succession planning.

President Ikenberry provided an update on the budget, taking into consideration the many uncertainties. The President said that the borrowing bill has stalled. Professor Tolliver said that there is anxiety among tenure-track faculty in that some are concerned that tenure might be denied based on the budget situation. President Ikenberry thought that this should be a talking point for chancellors and deans.

Vice President Knorr reported that the University's receivable from the state was \$478M as of today. Federal stimulus money and MAP funds were received last week. The University will have received \$288M of its state appropriation by the end of March. The University had collected \$400M the same time last year.

President Ikenberry said that the advocacy group is coming along nicely. The group has grown from 4,000 to 6,000 in the last few weeks.

Professor Eisenhart mentioned that the proposed legislation to discontinue 50% tuition waivers for dependents is dead this session but could come back. She expressed concern that the pension reforms for future employees could affect recruiting. President Ikenberry said that University employees have paid their premiums into SURS and SURS has performed on investments. The state has failed to do its part.

Vice President Knorr provided an update on the search for an executive director of governmental relations. The search committee, which he chairs, is almost finished interviewing. The goal is to have someone appointed at the May Board meeting.

President Ikenberry commented that he thought the report presented by Professor Burbules to the Board of Trustees went well. He said that he is comfortable continuing the practice. There was a discussion of other ways the faculty could connect with the Board, such as participating in Board committee meetings.

President Ikenberry said that Vice President Rao would be getting a group together to consider accelerated degree programs. 2-3% of students at the University already graduate in three years. Most have taken advanced placement courses and/or have earned dual high school/college credit, and many take advantage of distance learning opportunities. Vice President Rao's group will also look at expanding the summer session.

President Ikenberry is working with UIS leadership on the process to find a new chancellor. A search will most likely begin in the fall. The President provided an update on the presidential search.

In response to a question, Vice President Rao said that there would not be any changes to notification of appointment forms for this coming academic year.

Vice President Rao reported that two major committees are working on the Conflicts of Commitment and Interest policy. She plans to bring the policy to USC this summer. The revised policy needs to be in place by July 2011 in order to comply with an agreement made with the auditors. Vice President Rao said that automation of conflict reporting is being considered to make searching for information easier.

#### VI. <u>Old Business – Information and Discussion Items</u>

3. ST-74. Proposed Revision to the *Statutes*, Article I, Sections 2 – Term used to clarify the role of the President. Transmitted to Senates 10/26/09. Retransmitted with revisions 11/25/09. Endorsed UIS Senate 12/7/09. Accepted by UIC Senate 12/15/09. Approved UIUC Senate 2/22/10. Transmitted to the President 2/26/10. Approved by the Board of Trustees 3/10/10.

The Conference discussed the process for reviewing the vice presidents. All members will receive the accomplishments and goals of the vice presidents when they become available. The group had an immediate concern and unanimously agreed that Professor Eisenhart should discuss this with the President.

The Conference discussed the process and topics for the next presentation that will be given to the Board of Trustees. The group thought that ten minutes was a reasonable time allotment to be given for the presentation. Possible topics discussed were pension changes and the impact on recruitment and retention, as well as recruitment and retention in general, and sabbaticals. Professor Burbules commented that, while the University is losing faculty to other institutions, this may be the time for the University to do some cherry picking. Professor Patston said that Stanford has the practice of cherry picking professors who are on track to become Nobel winners and otherwise highly recognized.

The Conference discussed accelerated degree programs. Professor Burbules volunteered to get a group together to help generate the composition of a planning committee and a charge to the committee. Professors Campbell, Eisenhart, Ramsey, and Tolliver agreed to assist.

15. GR-41. Review of language in The General Rules, Article V, Section 3 – Private Use of University Property Forbidden.

Professor Weech said that there are some protections for the faculty by providing permission forms for using University property off-campus, and this could be broadened. Professor Campbell said that there could be a database of information.

16. OT-252. Vendor Code of Conduct.

17. ST-72. Consideration of the language in the Statutes, Article X, Section 2 (Academic Freedom).

Professor Tolliver reported that there is a proposal to strengthen the *Statutes*. The item is in the UIUC Senate's University Statutes and Senate Procedures. Part of the problem is that state employees are not protected from criticizing their employers; it is not considered free speech.

18. OT-123. Discussion of University Senates Conference guests.

The Conference discussed possible guests to invite to future meetings. The group also discussed the possibility of scheduling a special meeting to meet with the new president.

19. Campus Updates.

Professor Tolliver reported on budget planning going on at the UIUC campus. She suggested that there be better communication among the three campuses in terms of budget planning. Professor Tolliver said that representatives of the provost's office have agreed to have weekly meetings with representatives from the Senate Executive Committee. Professor Massat said that budget planning at UIC has not been faculty

driven. A committee with faculty representation was supposed to be appointed, but this has not happened. Professor Martin commented that faculty committees at UIS are there to be informed what is happening rather than to have a part in the decision-making process.
