Professor Terry Bodenhorn, Chair, called the University Senates Conference to order at 9:30 a.m.

V. Old Business – Information and Discussion Items

2. OT-229. University Administration Reorganization.

The Conference discussed the recent hiring of the Chief Financial Officer, the current search for a Vice President for Academic Affairs, and the review of the position of Vice

President for Technology and Economic Development.

Bodenhorn commented that the Board realizes that something has to be done soon. Grossman said that the Board's eighth guideline for a consensus solution recognizes that student athletes should be given the opportunity to compete without the University harming their ability to do so. Currently, the Chief is negatively affecting the welfare of some student athletes.

VI. Guest

Chancellor Sylvia Manning said that UIC has been preoccupied with budgetary issues. Numbers have been generated that show when tuition is increased, 18% goes to financial aid (tuition discounting) at UIC. In comparison, less than 4% goes to financial aid at UIUC. In addition, UIC starts with a lower tuition base. The good news is that UIC has the applicant pool to maintain quality.

Chancellor Manning commented that faculty continue to perform admirably. UIC is attaining a popular reputation. In a recent national ranking, UIC was placed in the top fifteen urban public research institutions. In the amount of research funding received, UIC is ranked 44 nationally. UIC is number one in underrepresented students at a research institution. There have been many positive changes in UIC's Development Office.

New programs are marked by the pushing of disciplinary boundaries. There are 43 proposals for interdisciplinary programs, mostly from faculty coming together on their own. The campus is improving student life with new residence halls and an improved student recreation center.

UIC is exploring the possibility of creating a charter high school by partnering with a successful charter network. UIC would help shape the math, science, and health curriculum and would provide enrichment activities.

Chancellor Manning commented on the Global Campus initiative. She mentioned that she was the Vice President for Academic Affairs in 1994 when she began thinking about increasing online education. In 1995, the mission to create UI-Online began. UIC has done very little online education but has the capacity to do much more through the School of Continuing Studies, for noncredit, and the Office of Extended Education, for credit. She believes the strength of online education at UIC will be through a blend of online and face-to-face education. She also believes online education cannot be separated from the faculty and the campuses. Also, the provosts need to be involved.

Bodenhorn thanked Chancellor Manning for meeting with the Conference.

VII. Executive Session

VIII. Guest

Trustee Bruce began by discussing the Global Campus. He said that he was not in favor of an LLC, and would like to see details of the business plan. He sees the initiative as a real benefit for those trying to get a degree and an education. If money is made from the Global Campus, that is great, but he hopes it is not the main purpose of the online initiative.

Trustee Bruce commented that the Chief issue has to focus on student safety and the welfare of the student athletes. The NCAA ruling has been appealed twice. Grossman indicated that basketball could be affected if it gets a NIT bid because the ruling could prevent the hosting of post-season games. Bodenhorn mentioned that at least 85% of student athletes are impacted negatively by the ruling. Kaufman expressed concern with safety and free speech issues caused by the Chief. Burton commented that people outside the University focus on the Chief issue, not the University's academic programs.

Trustee Bruce briefly discussed the budget outlook for the University.

Bodenhorn thanked Trustee Bruce for meeting with the Conference.

The discussion with Larry Mann resumed at 12:50 p.m.

Mr. Mann commented on USC's Permissible Use Policy. The Legal Counsel office has reviewed the recommendations in the proposed policy and has found inconsistencies with the state's ethics law. While the University feels its practices are not inappropriate, from a practical standpoint it seems best to leave the current policies in place and operate as usual.

Rick Schoell joined the meeting to discuss the dinner with legislators the evening before. He commented that Senator Maloney, Chair of the Senate Higher Education Committee, has been tremendously helpful to the U of I. He summarized Senator Maloney's point that it would be helpful for the University to demonstrate outcomes of investments in higher education and how these investments have a positive effect on society. He said that Senator Pritchard is a U of I alumni and was part of President Stukel's Advocate group. Senator Pritchard had pointed out that the state is going to continue to lag until the leaders learn to work together.

Mr. Schoell discussed the state's budget and other legislative issues.

Old Business – Information and Discussion Items (cont.)

There was general agreement among Conference members that the changes agreed to at the January 8 meeting should be incorporated into the document. However, some cautioned against spending too much time focusing on the wording of the document. Kaufman stressed that there must be assurance that the faculty will be part of all future discussions. Bodenhorn suggested that the Interim Academic Council include the provosts, faculty with experience in technology, and faculty with experience in shared governance. Grossman thought that there should be a five-year review of whatever is decided upon. Burton was concerned with the language of partnering with external units. Tolliver commented that recommendations made at the January 8 meeting should not be definitive because the document still has to be reviewed by the senates.

This issue was discussed with Larry Mann during the Executive Session. Bodenhorn commented that he could understand the reasons for not changing University policies. Grossman said that this issue came about when AAMT considered a fraudulent use policy that affected all employees but faculty were not involved in developing the policy. It was referred to USC and the senates, and then the UIUC GUP Committee developed the

Permissible Use Policy.
