MINUTES¹ UNIVERSITY SENATES CONFERENCE

DATE: Thursday, February 20, 2003

Professor Strom, Chair, called the University Senates Conference to order at 10:00 a.m.

I. Executive Session

II. <u>Guest – Trustee Lawrence Eppley</u>

Trustee Eppley discussed the budget situation and the State's concern with rising tuition costs. He said that these conditions challenge the University to create opportunities and the Board is willing to do whatever is ultimately good for the University.

Part of the challenge for Board members is to work with legislators in Springfield. Public universities bring money back into the State, one of the few components of the State budget that do so. Some Conference members could not understand why higher education has a bad reputation in Springfield and why legislators do not understand that the University uses best practices in its operations. Trustee Eppley did not know why the message was not getting through. He said that Vice President Gardner has provided very good data.

Professor Strom mentioned that the Senates Conference and the Senates have been interested in faculty representation on the Board, specifically a voice at the table. The group discussed ways the faculty could have a more active role with the Board. Vice President Gardner said that faculty members are involved throughout governance in ways such as serving on committees, including the Academic Affairs Management Team, and the Senates Conference meeting monthly with him and the President. Professor Fossum commented that the UIUC Senate Executive Committee has profited greatly from meetings with the Board liaisons.

Professor Strom thanked Trustee Eppley for meeting with the Conference.

III. Guest – Provost Michael Tanner

Provost Tanner said that the U of I will continue to thrive despite the current state of the budget. He discussed State support of the University and the value of financial aid.

Provost Tanner discussed the multiplicity of cultures of the Chicago campus and the tremendous opportunities for cooperative programs and research. He commented on the important roles of the faculty and the need for the administration to quickly deal with State expectations.

Provost Tanner projected that the economic health of the State will recover and Chicago is a terrific growth area. Some goals he sees for UIC is to maintain student diversity, assist in improving regional schools that feed into UIC, and become more engaged with Chicago.

Professor Strom thanked Provost Tanner for meeting with the Conference.

VI. Old Business – Action Items

1. ST-54. Amendment to the *Statutes*, Article IX, Section 10 – Nonreappointment of Academic Professional Staff. Passed UIUC Senate 3/19/01. Transmitted to Senates 5/18/01. Passed UIC Senate 9/28/01. Passed UIS Senate 11/30/01. Transmitted to the President 2/14/02.

The Conference agreed that this was not the right time to take this issue to the Board. Professor Chambers felt that the faculty should relay the message that academic professionals are valuable members of the community and should be treated in a valuable way. Professor Strom thought that the Conference should discuss with the President ways to improve conditions for academic professionals who are not full-time employees. The Conference agreed not to pursue ST-54 at this time, but to discuss the general issue of employment conditions for part-time academic professionals with the President.

Professor Strom commented that this was discussed with Vice President Gardner during the Executive Session

The Conference decided that the report from the subcommittee should be discussed further before it is decided whether it should be referred to the senates. Professor Strom suggested that the report be discussed when the subcommittee's chair, Professor Marshall, would be present.

7. OT-123. Discussion of University Senates Conference guests.

The Conference discussed possible guests to invite to future meetings.

8. Campus Updates.

Professor Jones said that UIC received permission from the Board of Trustees to use the title "University Librarian" for its search. The *Statutes* were changed a few years ago, as part of a cleaning-up process, and "University Librarian" was changed to "Campus Librarian". However, the other campuses still use University Librarian. Professor Jones asked if this was a topic the USC Statutes Committee should consider. Professor Kaufman, Chair of the Statutes Committee, said that he would look into it.

Professor Strom said that the UIC Senate is drafting policy as follow-up to ST-30. Professor Kaufman reminded the Conference that when each campus had its own policy in place, USC planned to compare them to make sure the policies were not significantly diverse as to create legal problems.

Professor Chambers noted that, according to information provided by the President earlier in the meeting, UIC was now above the University of Chicago in total research expenditures.

Professor Langley provided an update on the growing Capital Scholars Program and opening up first- and second-year courses to non-Capital Scholars Program students.

Professor Fossum said that the UIUC Senate Executive Committee passed a resolution in support of Chancellor Cantor in response to criticism of the Chancellor that relates to Chief Illiniwek. The full Senate will vote on the resolution the following Monday.

Professor Fossum said that he met with two people from the Provost's office to discuss multi-year contracts (ST-47). When the USC Multi-Year Contracts Task Force last met, the group was considering multi-year contracts for positions such as adjunct and clinical faculty, and academic professionals. Now, the UIUC campus sees reasons for not extending multi-year contracts to academic professionals at this time. Someone from the Provost's office was going to contact Professor Herricks, Chair of the Task Force, to request that the scope be changed so that academic professionals are not included. Professor Fossum added that the Provost's office is very interested in pursuing multi-year contracts for this limited group because the deans want them. Professor Kaufman said that the Board might accept multi-year contracts more readily if the long notice rights were reduced. Professor Fossum said that there is also the issue of dismissal for cause within the contract term. Professor Kaufman thought that the contract would contain provisions.
