Professor Thomas Conry, Chair, called the University Senates Conference to order at 10:00 a.m.

I. Executive Session

II. Guest - Dr. Kenneth Schmidt

Dr. Kenneth Schmidt, member of the Board of Trustees, received his medical degree from the College of Medicine at UIC. Dr. Schmidt is Chair of the Academic Affairs Committee of the Board of Trustees.

Dr. Schmidt distributed for information a document from the Association of Governing Boards, *Ten Public Policy Issues for Higher Education in 2001 and 2002*.

Dr. Schmidt commented that the University Administration has done a very good job of analyzing the impact of the budget cuts to the University and communicating the need for higher tuition. He said that the University should focus on philanthropy the next couple of years. However, there is not a need for new buildings. Instead, the University should focus on endowed chairs, professorships, and student scholarships.

According to Dr. Schmidt, some important issues facing the University are faculty recruitment and retention; core curriculum and general education requirements at UIUC; the University's role in, not only K-12 education, but K-16 education; and issues relating to non-tenure-track faculty.

Dr. Schmidt said that the UIUC research park is doing very well. Construction has started on the third building. The backlog of disclosures is being resolved. However, the hotel/conference center is on hold. At UIC there are 56 acres of research park. The incubator is managed by the Illinois Medical District Commission.

Dr. Schmidt reviewed the University's capital improvement items that were approved by the Governor. While the list is impressive, there is disappointment that funds were not approved for the Lincoln Hall remodeling and the Pharmacy addition.

Professor Kaufman said that University employees are in effect losing benefits due to the change of paradigm for the state funding of health insurance. Professor Conry commented that it was essential for CMS to spread the risk of rising health insurance costs throughout the whole state government, not just higher education.

Dr. Schmidt said that the base tuition increase is absolutely essential. The Board will vote on the issue in May. A report on the Chief will be presented in March.

Dr. Schmidt commented on a *Chicago Tribune* article, which attacked the University for raising tuition instead of making more cuts, and his subsequent letter to the newspaper. He said that the U of I is such a great bargain, even with the proposed tuition increase. Also, the University has a very small pool of recurring funds that are accessible for budgetary cuts. Dr. Schmidt said that the University is in line with other institutions in allocating 5% of its budget to administration, although there is a layer of middle management that needs to be examined.

Dr. Schmidt said that the initiative of assigning three trustees to each campus has opened dialogue with the faculty and has been useful.

Dr. Schmidt said that many legislators have the perception that faculty do not do enough. Many look at the average contact hours with students, 11.2-12.6 per week, and do not understand all of the time that is involved outside of the classroom. He added that it is up to the faculty to articulate faculty productivity. Professor White said that the faculty bring in \$572M in research grants. Dr. Schmidt added that these grants come in because of the faculty, not the University.

Conference members said that there is a wide array of expertise available in the faculty and suggested that the Board utilize this expertise more often. Dr. Schmidt said that the trustees are accessible to the faculty.

Professor Conry thanked Dr. Schmidt for meeting with the Conference.

Professor O'Brien questioned the text in parenthetical brackets on the first page, second paragraph under *Executive Session*. Professor Conry explained that the unexpected increase, the percentage over the original 5% UIUC – 4% UIS – 3% UIC, would amount to an average of \$100 per student per semester. The overall increase would be about \$200 per student per semester. Professor O'Brien suggested changing "and the total increase would be" to "bringing the total increase to..." The minutes were approved as amended.

V. Old Business – Action and Discussion Items

1. OT-183. Recalculation of USC Membership.

Professor Conry said that this issue would turn on the way in which the Conference decided to define faculty. Professor Langley said that she believed the options were to not change the representation, or to re-evaluate the apportionment based on the number of faculty used by each senate when defining its membership. Professor Zaki said that the faculty numbers for each campus were not conclusive. He did not believe it would be in the best interest of the Conference to have a family feud over whether to change the current representation. Professor Strom said that he and Professor Conry discussed the situation and decided that the Conference does have an obligation to re-examine the apportionment of the membership every five years, according to the *Statutes*. Professor Kaufman thought that if USC used the faculty number reported by each senate, which was the number of eligible faculty each senate used to determine the apportionment of its membership, the USC apportionment would be about the same. Professor Strom made the motion that the Senates Conference has examined the issue of representation and feels that no change is appropriate at this time. The motion was seconded, voted on, and unanimously approved.

2. ST-47. Proposed Revisions to the Statutes -- Multi-Year Contracts for Full-Time Non-Tenured Faculty. Passed UIC Senate 10/27/99. Rejected UIS Senate 3/3/00.

Professor Conry said that he wrote the chancellors and provosts asking for one administrator-designee per campus to serve on a task force with the purpose of addressing issues relating to multi-year contracts. He reported that Ms. Kathleen Pecknold had been designated as the Urbana person. Professor Conry asked for volunteers from USC to serve

on the task force. Professors Robert Fossum, Edwin Herricks, Elliot Kaufman, and Pat Langley volunteered to serve.

Professor Fossum warned that this is a very contentious issue that should be approached cautiously. Many colleagues believe that this is a real attack on the tenure system. He said that he personally believes multi-year contracts are important to the University. Professor Conry remarked that this would not be a policy applied across the board.

The other resolution requests that the Conference either reaffirm to the President the language approved by all three senates or ask that the proposed amendment be placed on hold until the other senates have the opportunity to consider alternate wording.
