Professor Thomas Conry, Chair, called the University Senates Conference to order at 10:02 a.m.

I. <u>Executive Session</u>

II. Guest - Vice President David Chicoine

Vice President Chicoine reviewed the presentation he gave to the Board of Trustees in January on behalf of the Board's Committee on Economic Development. The committee recommended that IllinoisVENTURES, LLC be a start-up services company that would assist in the transfer of technology from the lab to the commercial world. This will create jobs and business opportunities. IllinoisVENTURES, LLC will not be in the business of raising venture capital. The committee also recommended the creation of an executive advisory committee.

Economic development at the U of I includes intellectual property protection and technology management by the Offices of Technology Management, state-of-the art research parks and incubator facilities, mentoring and start-up services for promising new companies, and relationships with the corporate, business, and public sectors.

The 56 acre Chicago Technology Park is managed by the Illinois Medical District, of which Dr. Kenneth Schmidt has been a long-time member. The University of Illinois Research Park in Urbana has a board of eleven members: five external members, the Governor, two trustees, two deans, and the UIUC Vice Chancellor for Research. Ground was broken in December for the \$8M incubator facility.

Vice President Chicoine said that IllinoisVENTURES, LLC provides world-class support for promising start-up companies so that new technologies can get to the private sector as soon as possible. He is a member of the IllinoisVENTURES, LLC board. The University takes an equity position in new companies. The revenue flow is divided up 40% to the campus, 40% to the inventor(s), and 20% to the unit of the inventor(s).

Vice President Chicoine reported that the Office of Technology Management at Urbana has made substantial progress. The backlog of intellectual property disclosures has been dealt with and new disclosures are back to faculty in six weeks.

Vice President Chicoine said that the UIC and UIUC campuses have the potential to build business relationships that no other institution in Illinois can accomplish. Professor Conry thanked Vice President Chicoine for meeting with the Conference.

V. <u>Campus Updates</u>

Professor Herricks reported that the UIUC Senate requested that its University Senates Conference members encourage the Conference to move forward the version of ST-30 that was approved by the senates. The Conference acknowledged the receipt of the message.

Professor Jones told the Conference that the provost-designate met with the UIC Senate Executive Committee and each side was appropriately impressed with the other.

Professor Langley said that the UIS Senate recommended minor changes in order to clarify the language. Professor Strom moved to approve the language approved by the UIS Senate and send it to Vice President Gardner. The motion was seconded, voted on, and approved.

Professor Strom mentioned that the discussion during the Executive Session concluded that it would be three years before any vice president had been in position for five years. Professor Conry said that another issue to consider is how to handle the annual reviews. He suggested that the Conference have a discussion each year with the president at either the April or May meeting to talk about the performance of the vice presidents. Professor Kaufman assumed that the vice presidents submit information each year to the president for his evaluation and thought it would seem reasonable to ask the president to share the information with the Conference. Professor Fossum suggested that the Conference ask the president to send a letter to the vice presidents informing them that the president is reviewing their performance and has asked USC to assist in the review process. The vice presidents would be asked to send information to the Conference. The Conference would review the information and then discuss it with the president. This would be done annually since appointments are done annually. Professor Alston commented that the USC minutes would provide a paper trail indicating that the review had been done. Professor Strom suggested that the Conference discuss the process with President Stukel

at the next meeting.

Professor Kaufman said that the seminar has been meeting monthly. The group has come to the conclusion that economic development is a very broad term that has been vaguely defined and would be better defined as business development through technology transfers. Two working committees were created. The Faculty Principles Committee is focusing on such issues as promotion and tenure and conflict of commitment and interest. The Resource Allocation Committee is focusing on such things as looking at the kinds of resources the University is putting into these activities and considering what is appropriate. Both committees have submitted draft reports. The goal is to create a report to be read both inside and outside of the institution that will consider how we should be approaching these activities, what kind of faculty input is needed, and what kinds of checks and balances should be in place. The seminar hopes to have the draft document completed by the end of the spring semester and wants wide distribution within the

University with the intention of receiving feedback. A final report would then be distributed in the fall.
