#### UNIVERSITY SENATES CONFERENCE

Professor Thomas Conry, Chair, called the University Senates Conference to order at 10:00 a.m.

#### II. Guest – Provost Michael Cheney

Provost Cheney met with the Conference for lunch and then made a few brief comments. He said that the past year has been a tremendous learning experience for him. UIS intends to achieve excellence as a public liberal arts institution, but on a scale that fits its size. The campus has hired a lot of junior faculty and recruited an excellent group of students for the Capital Scholars Program. There will be one hundred new students each year in the Capital Scholars Program. There is enough room for 200 students in the residence halls. Townhouses will be built to accommodate other students that choose to live on campus.

Professor Conry thanked Provost Cheney for meeting with the Conference.

## V. Campus Updates

Professor Kopecky commented that UIS will run the academic aspects of the Lincoln Library and Museum. Professor Leonard said that the UIS Senate was unhappy that the faculty had not been consulted on the decision for UIS to have a basketball team and on the hiring of the coach.

Professor Fossum said that the main issues at UIUC are the negotiations with the GEO and the budget.

#### VI. <u>Old Business – Action and Discussion Items</u>

1. OT-187. UI-Integrate/Support Services Strategy (S<sup>3</sup>) Related Issues.

Professor Conry commented that Professor O'Brien had suggested combining the issues of UI-Integrate (OT-162), Support Services Strategy (OT-158), and ERP-Related Academic Policy Issues (OT-179) into one topic, which would be OT-187, UI-Integrate/Support Services Strategy (S3) Related Issues. Professor Strom moved to combine the three items into one topic. The motion was seconded, voted on, and approved. Professor Conry asked if topics OT-158, OT-162, and OT-179 should then be removed from the agenda. Professor Weller made a motion to do so. The motion was seconded, voted on, and approved.

Professor Conry said that he asked Professor White to chair the committee and Professors Kopecky and Zaki to serve as the other members. He noted that the new USC members had been elected by the senates. Professor Conry also commented on the UIS Senate's election, which started a current USC member with a new three-year term without finishing out the current term. He clarified that members cannot switch to a new term when the current term has not been completed. Professor Kopecky said that the UIS Senate would look into the situation.

6. ST-47. Proposed Revisions to the *Statutes* -- Multi-Year Contracts for Full-Time Non-Tenured Faculty. Passed UIC Senate 10/27/99. Rejected UIS Senate 3/3/00.

Professor Conry reported that the task force to look at multi-year contracts had its first meeting on April 11. He said that Professor Herricks is chairing the committee. Professor Kaufman commented that the task force identified some clear, immediate goals. The intent is to focus on very specific areas or job categories where a simple multi-year contract scenario would be created for that group, and then think about a global approach later. Professor Zaki asked if it was appropriate for this body to be making policy for academic professionals. Professor Kaufman said that the task force had actually taken academic professionals off of the table for now and would be concentrating on academic staff. Professor Conry added that it was appropriate since statutory changes would be required.

Professor Fossum said that he would draft a proposal for the annual reviews of the vice presidents based on the process used by UIUC to evaluate vice chancellors. The Conference agreed that the reviews should be oral and the USC minutes would reflect that the reviews had taken place.
