V. <u>Old Business – Information and Discussion Items</u>

1. OT-205. Presidential Search.

Professor E. Kaufman said that the white paper, which was approved by the Board of Trustees, is a tool to define what type of person the consultative committee should be looking for. The committee will outline more specific requirements of the position. The search firm will be collecting nominations and applications. The pool of candidates will be reviewed in September, and interviews will probably be held in early October. The consultative committee will generate a short list, which will be submitted to the Board. Professor E. Kaufman noted that this is the only presidential search that the search firm is handling at this time.

The Conference discussed the various campus policies related to e-mail. Professor Ford commented that the UIUC policy was more developed than the policies at UIC and UIS. Professor E. Kaufman thought that it makes sense to have a university-wide policy governing e-mail. Professor Langley said that Homeland Security federal law would have to be taken into account. The Conference decided to create a task force to examine the possibility of developing a university-wide policy.

7. Campus Updates.

Professor Grossman reported that Provost Herman would be naming an acting provost and that he had asked the UIUC Senate Executive Committee for names. He also mentioned that the Senate would be doing its yearly review of the vice chancellors during the summer. Professor Jones said that the LAS dean search was unsuccessful so there will be an interim dean. However, the College of Engineering does have a new dean. He also commented on changes to make the campus more friendly and attractive to students. Professor Langley commented that the chancellor and provost have been contacted about unilateral academic decisions that have been made without input from the faculty.

VI. <u>Guest</u>

Dr. Richard Herman said that the University is in negotiations with the Graduate Employees' Organization. Salary and health care benefits are being discussed. He commented on the Conference's concern that some academic appointments are being delayed. Dr. Herman responded that efforts are being made to improve the process and some complications have been the result of multiple-source funds. He added that student

registration went very well. Some grants are not being paid in a timely manner. Dr. Herman acknowledged that the Chief Illiniwek controversy has caused great polarization. He noted that the sponsors of the consensus resolution are on opposite sides of the issue. He also commented on the involvement of the legislature and North Central Association.

Dr. Herman said that decreasing state funds is one of the most challenging issues facing the University. For the first time, non-state funds will exceed state funds in the amount of dollars spent per student. In order to achieve excellence, the infrastructure should be rebuilt by picking the right areas in which to invest. He said that the last fundraising campaign added 32 named positions to the Urbana campus, bringing the total to approximately 240. Matching funds, graduate fellowships, and scholarships for undergraduates are very important.

Dr. Herman commented on the University's obligations as a land-grant institution. The University's economic role plays an important part by contributing to the well-being of the state. He said that the research park has been a success.

Dr. Herman closed by asking the Conference to please seriously consider multi-year contracts.

The Conference members thanked Dr. Herman for meeting with them.
