MINUTES1

UNIVERSITY SENATES CONFERENCE

DATE: Thursday, September 20, 2001

PLACE: President's House, Urbana

Professor Thomas Conry, Chair, called the University Senates Conference to order at 10:00 a.m. He requested a moment of silence in remembrance of the victims of the September 11 terrorist attacks.

I. Executive Session

II. Guest

Professor Conry welcomed Chancellor Nancy Cantor. She said that she would like for the Conference to provide feedback to her on issues to be discussed. Professor Strom commented that the Conference's role is defined in the *Statutes*, but its most important function is to advise the President.

Chancellor Cantor said that the Urbana campus took big hits in faculty lines several years ago. Humanities and social sciences need to be made more visible. The remodeling of Lincoln Hall is high on the list of priorities. One question she has been thinking about is how to make sure the pieces of the campus come together. There needs to be a clear linking of programs. Chancellor Cantor said that she believes that it is important to build the humanities and the social sciences by increasing their ties to interdisciplinary programs, but not at the expense of the humanities and social sciences disciplines. The Chancellor said that she was committed to rebuilding faculty numbers.

Chancellor Cantor said that the campuses should not spend a lot of time thinking about the redundancy of the programs among the campuses. Rather, more time should be spent on synergy – thinking about what could be built together.

Chancellor Cantor told the Conference that she believes the University of Illinois is too quiet of a jewel and needs to get a lot noisier. The University should coordinate with alumni groups around the country and have more of a presence in the geographics of the student body. It is important to be at the right tables. She said that it is very important to move towards a more national student body, and added that it is possible to do this without necessarily taking away from the number of in-state students.

Chancellor Cantor was asked to comment on the present budgeting situation. She said that the collective units have to be fed while dispersing to departments. She added that the process can be cumbersome with the different layers of the budget.

The Chancellor was asked to comment on the plan for UIUC to become more visible in Chicago. She said that there would be connections in the fine and applied arts, commerce, and law. Chancellor Cantor added that she would like to see more connections with the UIC health sciences, life sciences, and biotechnology.

Chancellor Cantor said that, while the University needs a central voice, it is each campus that knows its own strengths.

Professor Conry thanked Chancellor Cantor for meeting with the Conference.

VI. Old Business – Action and Discussion Items

1. ST-30. Proposed Changes to the *Statutes*: Terms of Faculty Employment. Passed UIUC Senate 4/21/97. Passed UIC 3/11/99. Passed UIS 4/30/99. Passed USC 9/8/99. Transmitted to the President 9/15/99. Resent to the Senates 12/13/99. Response from UIC 1/27/00. Response from UIUC 2/14/00. Transmitted to Senates 7/18/01.

The Conference discussed whether the final word against sanction should rest with the provost or the elected committee. Professor Fossum said he had been advised by members of the administration that the authority of the chancellors should not be impinged upon. The general feeling of the Conference was that each senate should determine the language it believes is appropriate.

2. OT-89. Fitness to Work. Passed UIUC Senate 2/24/97. Passed UIC Senate 4/23/98. Passed UIS Senate 9/24/99.

Professor Conry said that the President indicated that there should be a uniform policy. Professor Kaufman suggested that this item be referred to the USC Statutes Committee. Professor Fossum asked if the President had formally responded to the Conference's proposal that each campus determine its own policy. Professor Kopecky said that he had informally discussed the issue with the President, who indicated a preference towards a uniform policy. Professor Kaufman made a motion that Professor Conry get a clear indication from the President whether he would accept the Conference's proposal or whether he would like for the Conference to further pursue a uniform policy. The motion was seconded. Professor Fossum recommended that the Conference vote down the motion and instead ask the President for the opportunity to discuss the issue with the full Conference. The motion was approved with one opposing vote.

3. OT-181. Proposed Revisions to the *Policy and Procedures on Academic Integrity in Research and Publication*, Section IV.B.2. Transmitted to the President 7/13/01.

Professor Fossum said that the UIUC Senate Council decided that appeals should be made to the Vice Chancellor for Research rather than to the Provost, as was originally recommended by the senate's Committee on General University Policy. Professor Kopecky said that he did not believe this item was an issue for UIS. Professor Strom moved that the language, with the change proposed by UIUC Senate, be sent to the UIC Senate for consideration. Professor Rich suggested that the document be sent to the UIS Senate as well. The suggestion was accepted as a friendly amendment. The motion was voted on and approved.

4. OT-176. Periodic Vice President-Level Reviews. (Recommendations to the President: Revision of duties of the Vice President for Academic Affairs; Creation of a Vice President for Economic Development and Corporate Relations.) USC Proposal to the President 1/10/01

Professor Kaufman moved that this item be removed from the agenda. Professor Conry said that reviews fall under the new agenda item, OT-184, Committee on Vice Presidential Search Procedures and Processes for Commenting on the Reappointment of University Officers. The motion was seconded, voted on, and approved.

Professor Kaufman reminded the Conference that when the position of Vice President for Economic Development and Corporate Relations was created, the Conference made it clear that academic research should remain in the Office of the Vice President for Academic Affairs. Professor Rich suggested that Professor Conry inform the President that the Conference would like to discuss with him where research resides. The Conference agreed.
