Class II:	Matters affecting more than one campus. Item is sent to Senate(s) for action, then to President and Board of Trustees. At the time of this classification, the Conference member will file with the recording secretary an accurate final copy of the Senate action.
Class III: 	Amendments to the <i>University of Illinois Statutes</i> . Procedure is the same as with Class II items. At the time of reporting this classification, the Conference member will file with the recording secretary an accurate final copy of the Senate action.
Class N: 	This designation requires no USC action, but alerts one or more Senates to an item of interest from the originating Senate. The "N" is preceded by and followed by a lower case letter(s); $c = Chicago$; $s = Springfield$; $u = Urbana-Champaign$; usc = University Senates Conference. Example: "cNs,u" means that a matter has come up in the Chicago Senate, which may be of interest to Springfield and Urbana-Champaign.

Pending her willingness to continue, it was decided that Professor Weller would remain on the committee until the current cycle of the tuition process was complete. Professor Wood agreed to serve during the next cycle.

10. OT-211. Process for Selecting Board of Trustees Members.

Professor Grossman said that, during the Annual Meeting of the Faculty at UIUC,

Professor Stephen Kaufman asked him if the Senate or the Senates Conference would consider taking up the issue of whether the current mechanism by which Trustees are apportioned and appointed best serves the governance of the University. Professor Grossman distributed correspondence from Professor S. Kaufman. After discussion, the Conference decided that it might not be a good idea to take ownership of this issue. A more important issue is to ensure that qualified people are selected to serve on the Board. Professor Grossman said that there is literature from the Association of Governing Boards that might be useful.

V. Old Business - Information and Discussion Items

11. OT-208. E-Mail Security Policy.

Professor Langley commented that some universities have statements that say e-mail privacy will be protected unless there is reason to believe there is illegal activity, but the default is privacy. However, there can be abuses because the employer owns e-mail and has every right to view it. Professor Langley recommended that the Conference meet with Mr. Keith Miller from UIS, who is knowledgeable about these issues.

12. OT-123. Discussion of University Senates Conference guests.

The Conference discussed possible guests to invite to future meetings. Professor Grossman proposed meeting the night before regular USC meetings a few times a year. The Conference decided to have an evening meeting at each campus once per year, pending funding approval.

13. Campus Updates.

Professor Langley said that there are still struggles with the campus administration. Professor Grossman said that the UIUC Senate had its first meeting of the year the day before. Interim Chancellor Herman intends to form a faculty committee to look into whether the Chief has a negative effect on education. Professor W. Jones said that Provost Tanner had appointed a 2010 Vision committee.
