MINUTES¹ UNIVERSITY SENATES CONFERENCE

DATE: Thursday, November 16, 2006

Professor Terry Bodenhorn, Chair, called the University Senates Conference to order at 9:30 a.m.

I. Old Business – Information and Discussion Items

1. OT-227. The Global Campus.

Bodenhorn provided copies of recent correspondence from President White and Dr. Gardner concerning the Global Campus. The Conference discussed the documents as well as four key questions concerning the Global Campus in a letter that President White sent to Bodenhorn. The Conference agreed that the first two questions were basically stating goals for a high quality program and were void of any real discussion topics. The answers to the last two questions needed thoughtful consideration.

There were questions and concerns regarding the flow of money for salary lines, who does the hiring, employee rights, and how an LLC would affect these issues. There were also concerns with the hiring criteria for instructors, engaging students, keeping courses up-to-date, and the role of faculty in the long-term. Kaufman said that the intention is to partner with units in developing courses and use a master teacher model. He saw no reason why partnering with units would end, although there might be exceptional cases where there would be no partnering unit.

Mallory thought that the issue of the Chief should be resolved before the University goes global. Several members commented that the two issues should be kept separate.

Wheeler and Ford described incidents on their campuses where money for existing online programs through UI Online has been diverted to funds for the Global Campus. They

were under the impression that existing programs were not to be affected by the initiative. Schacht commented that the UIUC Senate Global Campus Task Force met with President White and Dr. Gardner. There was some indication that the President and Dr. Gardner would be willing to consider an alternate model. The task force will be issuing a report in the near future.

Bodenhorn said that he would not be present for the discussion with Jim Weyhenmeyer regarding intellectual property. Schacht mentioned problems with new language to *The General Rules* that gives the University proprietary rights with respect to electronic materials developed for teaching. This is in conflict with language in the courseware policy. He cited another problem in *The General Rules* regarding use of University facilities and resources. Vice President Chicoine, who had joined the meeting a few minutes earlier, said that he had consulted Larry Mann about this issue. Mr. Mann indicated that the changes proposed in the Conference's Permissible Use document get entangled with the new ethics law.

III. Guest

Associate Vice President Jim Weyhenmeyer met with USC to discuss proposed changes to *The General Rules* and supplemental policies regarding intellectual property issues. Mr. Weyhenmeyer said that the Intellectual Property Committee will make adjustments once feedback is received. He commented that the courseware section attempts to make a statement and is not intended to change policy.

Wheeler questioned the addition of "experimental results" as intellectual property. Mr. Weyhenmeyer responded that it was added as a protection and for the ability to retrieve materials in a timely manner if needed for a court case.

Kaufman commented that a course used to be the person but now with Power Point, etc., there is something to market. The nuance is that faculty members may want to make a deal with their unit if there is the possibility of marketing the course. Mr. Weyhenmeyer said that the language was written with the intention of driving a process that encourages the creator and administrative unit to have a conversation early on. Ford said that the problem is that ownership defaults to the University according to *The General Rules*.

Mr. Weyhenmeyer and the Conference discussed licenses, patents, start-up companies, and how the Office of Technology Management is involved.

Mr. Weyhenmeyer commented that the supporting documents are for operational purposes and are intended to allow faculty to be as productive as possible. Putting everything into

The General Rules would be impractical.

Bodenhorn thanked Mr. Weyhenmeyer for meeting with the Conference.
